Probate Introduction

WHAT IS PROBATE?

Probate is the legal process of sorting out all the property, money, possessions and debt of someone who's died. Going through probate usually includes gathering a lot of information, applying for a Grant of Probate, selling property and possessions, and sharing out what's left.

FREQUENTLY ASKED QUESTIONS

Do I need probate?

In some simple cases you may not need probate – but you'll probably need it if the person who died owned property or they had more than $\pm 5,000$ to $\pm 10,000$ in a bank (the exact amount depends on the bank).

How long does probate take?

The time from someone dying to receiving your inheritance is often six months to a year – but it varies depending on quite a few factors.

What is a Letter of Administration?

A Letter of Administration, or Letters of Administration, is an official document that authorises an individual (or individuals) to legally manage the estate of someone who has died without a will.

Is there a deadline for probate?

While there is no specific timeframe for finalising the probate process itself, any inheritance tax owed on the estate must be settled within six months from the date of the individual's passing.

Do I have to pay inheritance tax?

There's no inheritance tax to pay if the estate is worth less than £325,000, or £500,000 in some circumstances. Above that, you'll typically pay 40% tax, however you may be able to claim further exemptions/reliefs.

Who is responsible for paying inheritance tax?

The estate's executor or administrator is responsible for paying inheritance tax in most cases.
